Explanation of Responses:

1. Note that 821,452 of Mr. Snyder's shares are held directly and that an additional 1,129,796 shares are held indirectly as follows: 170,900 and 266,062 shares in the 2014 and 2013 Susan J. Snyder Grantor Retained Annuity Trusts held in the name of his wife Susan, respectively; 290,000 shares in the Charles J. Snyder 2013 Grantor Retained Annuity Trust and 402,834 shares in the Charles J. Snyder 2014 Grantor Retained Annuity Trust.

Remarks:

Prior to the 2013 Annual Meeting of Stockholders, the Board of Directors of FactSet accepted the resignation of Charles J. Snyder, Vice Chairman of the Board of Directors and Director, and related responsibilities as a member of the Nominating and Corporate Governance Committee. Mr. Snyder's resignation was effective December 17, 2013, concurrent with the expiration of his current term and the date of FactSet's 2013 Annual Meeting of Stockholders. Accordingly, as of the date of the filing of this Form 5 (which is six months from the date of Mr. Snyder's resignation on December 17, 2013), Mr. Snyder is no longer subject to Section 16 of the Exchange Act.
